WAKE ROBIN PROVIDES RESIDENTS WITH HOUSING, HEALTH CARE SERVICES, FOOD SERVICES, SECURITY AND OTHER ANCILLARY SERVICES TO THE SENIOR RESIDENTS. AT DECEMBER 31, 2017, THE COMMUNITY HOUSED APPROXIMATELY 261 RESIDENTS IN INDEPENDENT HOMES AND 67 RESIDENTS IN THE HEALTH CENTER.
